COSEWIC - arms length from government: just looking at candidate **listing**, **prioritization and assessment** 

Using best available information(includes ATK aboriginal traditional knowledge)

COSEWIC membership and chairs have a term limit, often adding new members. There are REGULAR calls for new members (volunteer position). However, the smaller committees tend to hold on to people longer. Expenses for committee meetings (travel, hotel) are paid for. Co-chairs receive honorarium.
