- **Judging Panel:** The judging panel will consist of six (6) judges that belong to CAZA and the accredited facilities.
- **Notification:** Winners will be notified via their social media accounts before August 9.
- **Claiming the Prize:** Winners must indicate their intention to use the prize by August 15. If the prize is not claimed by this date, the Organizer reserves the right to select an alternate winner.
